Summary Paragraph

The Town & Country Center is an out-door shopping center designed in the International Style and constructed in (1948). Located in the heart of downtown Palm Springs, the Town and Country Center was designed by two internationally famous architects, Paul R. Williams and A. Quincy Jones. The complex consists of four original buildings and a fifth building constructed in 1955 and designed by Donald Wexler, Architect. The two street-facing elevations vary in style, materials, and appearance having varied geometry and quantity of fenestration; however, they share materials of painted concrete and stucco walls, storefront spaces with metal framed window walls, and other fenestration of fixed framed windows along both east & west elevations are consistent. The buildings are steel framed, with partial basements and concrete foundations. Flat roofs are consistent in all buildings. The fifth building, added in 1955, is constructed of concrete, metal & glass, has a flat roof, and responds to the original design documents produced by Jones & Williams illustrating a future building to be constructed at it's current location. The Town & Country Center retains most aspects of historic integrity including, location, design, setting, materials, workmanship, feeling and association.

Statement of Significance Summary Paragraph (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The Town & Country Center is eligible for the National Register under Criterion "C" under the category of "Architecture". The Town & Country Center's ability to exemplify the city's emergence as a modernist destination qualifies it for listing under the category of Architecture. The Town and Country Center is one of the best examples of the International Style of architecture in southern California, and is an important early "mixed use" development. It is also architecturally noteworthy for it's pedestrian friendly open-air courtyard which creates passage between two prominent streets, Palm Canyon Drive and Indian Canvon Drive. The subject property was comprised of three, two-story, flat roofed elements surrounding the open-air courtyard on four sides. These building elements can further be distinguished as four buildings, with a fifth building consisting of a one-story, flat-roofed structure constructed in 1955. Along the east side of the courtyard, a wide staircase leads to a second level restaurant space, originally called the Town & Country Restaurant, now vacant. Along the northwest corner of the courtyard is a semi-circular element that recalls Erich Mendelssohn's famous and influential International Style De La Warr Pavilion of 1938, considered by some to be Britain's first Modernist building. The period of significance is 1948-1955, when post World War II modernism was in its heyday in the city of Palm Springs. The Town & Country Center clearly reflects the collaborative work of two distinguished master Architects (A. Quincy Jones & Paul R. Williams), and an additional building later added by a third master Architect (Donald Wexler). There is also evidence, based upon the original drawings of the Town & Country Center, that two other distinguished master Architects (Albert Frey & John Porter Clark) collaborated with Jones & Williams on the design of the retail suites fronting North Palm Canyon Drive.








